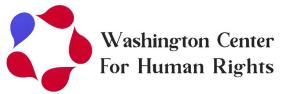

# **Executive Summry**

The human rights situation in Palestine in 2024 is marked by extreme violations and an escalating humanitarian crisis driven by ongoing conflict and political instability. The circumstances on the ground call for urgent international intervention to address these critical issues.

Israeli military operations in Gaza have resulted in more than 37,600 Palestinian deaths since October 2023, alongside widespread destruction of infrastructure, displacing a significant portion of the population. In the West Bank, reports of systematic oppression, including illegal settlements and forced displacements, have raised alarms, with some human rights organizations describing the situation as apartheid. Allegations of using starvation as a method of warfare, and the obstruction of humanitarian aid, further exacerbate the crisis. Arbitrary detention and torture are also widespread, with both the Israeli authorities and the Palestinian Authority facing accusations of unjustly imprisoning political dissidents.

Palestinian armed groups, particularly Hamas, have also contributed to the violence, with indiscriminate rocket attacks on Israeli civilians causing significant casualties. Hostage-taking incidents have raised additional concerns, with reports of gender-based violence occurring in such situations.

Despite the grim situation, some progress has been made. International legal bodies, including the International Criminal Court (ICC), are investigating potential war crimes by both Israeli and Palestinian actors, aiming to bring accountability. Humanitarian aid efforts are ongoing, though frequently hindered by blockades and military activities, while the United Nations has passed resolutions urging Israel to comply with international law, although enforcement remains a challenge.

The humanitarian crisis in Gaza is overwhelming, with 96% of the population dependent on external aid for survival. Political divisions between Fatah and Hamas further weaken governance and response to the escalating human rights abuses, leaving the population vulnerable to continued violence, including extrajudicial killings and arbitrary detentions.

Key recommendations include an immediate ceasefire by Israel, the lifting of the blockade on Gaza, and independent investigations into alleged war crimes. The Palestinian government is urged to hold armed groups accountable and strengthen legal protections for women and human rights defenders. International bodies and civil society organizations are called upon to facilitate dialogue, advocate for victims' rights, and ensure the unimpeded delivery of humanitarian aid.

In conclusion, the human rights landscape in Palestine remains critically unstable, necessitating coordinated efforts from all involved to address the violations and support the affected population.

# Methodology

The methodology employed in gathering data for human rights reports on Palestine, especially during the significant events of 2024, is a nuanced and multifaceted approach that combines both qualitative and quantitative strategies. This comprehensive framework is crucial for accurately capturing the complex realities of human rights violations in a region characterized by conflict and political unrest.

#### Sources of Information

Data collection predominantly relies on a mix of primary and secondary sources:

#### Interviews:

Human rights organizations frequently conduct interviews with victims, witnesses, and local activists. These firsthand accounts are vital for understanding the personal impacts of systemic abuses. However, the fear of reprisal can limit participant engagement [1][2][7].

#### Field Research:

Researchers undertake direct observation and documentation of conditions in areas such as Gaza and the West Bank. This involves assessing living conditions, access to essential services, and the security landscape [3][6].

## **Reports from Local NGOs:**

Local non-governmental organizations (NGOs) are instrumental in monitoring human rights conditions. Their reports provide detailed incident accounts, often illuminating issues that may be overlooked by international bodies. However, these organizations often face operational challenges due to restrictions imposed by Israeli authorities [4][5].

#### **International Reports:**

Data is also drawn from publications by international organizations such as Human Rights Watch and Amnesty International, which offer broader context and analysis based on extensive research [2][7][8].

#### **Government and UN Documents:**

Official documents from the Palestinian Authority (PA) and various United Nations reports help frame the legal contexts and policies affecting human rights in Palestine [1][5][6].

#### **Data Collection Methods**

The methodologies used for data collection include:

### **Qualitative Analysis:**

This method involves thematic analysis of interview transcripts and field notes to identify patterns related to human rights violations, such as arbitrary detentions or violence against civilians [3][4][5].

#### **Quantitative Data:**

Some reports integrate statistical data on casualties, arrests, and other metrics to enhance the understanding of the scale of violations [2][7][6].

#### **Collaborative Research:**

Many organizations collaborate to enhance the credibility and comprehensiveness of their findings. For example, joint reports between Palestinian NGOs and international entities can strengthen the overall impact of the data presented [1][5][7].

# **Limitations and Challenges**

The research process encounters several significant challenges:

#### **Access Restrictions:**

Israeli military restrictions severely limit access for human rights workers to Gaza and certain areas of the West Bank. This not only hampers data collection but also raises concerns regarding the reliability of the information gathered under such constraints [2][3][8].

# **Safety Concerns:**

The volatile security situation creates an environment in which researchers must navigate significant risks, potentially deterring comprehensive data collection efforts [2][7][6].

# **Fear Among Participants:**

Many potential interview subjects express fear of retaliation or repercussions from authorities, leading to underreporting or incomplete data [1][5][8].

#### **Political Biases:**

The politicization of human rights reporting can skew data interpretation. Reports may face criticism for bias depending on their sources or affiliations, complicating efforts to achieve consensus on findings [3][4][8].

#### **Resource Limitations:**

Many local NGOs operate with constrained funding and capacity, which can impact their ability to conduct extensive research or advocacy effectively [5][6][7].

In conclusion, while the methodology for collecting data on human rights in Palestine is robust in its diverse sources and methods, it faces significant challenges that may affect the accuracy and completeness of its findings. The ongoing restrictions imposed by Israeli authorities further complicate these efforts, underscoring the need for continued advocacy for greater access and protection for those documenting human rights conditions in the region [2][5][7].

# **Human Rights Overview**

The human rights situation in Palestine for 2024 remains critically dire, shaped by ongoing political, economic, and social challenges exacerbated by recent escalations of violence and international responses (1)(2)(3). This overview highlights the multifaceted context impacting human rights in the region, focusing on significant events that have influenced the landscape.

#### **Political Context**

The political environment in Palestine is characterized by a long-standing occupation and internal divisions, particularly between the Palestinian Authority (PA) and Hamas (3)(4). The PA has faced criticism for its governance and human rights abuses, including arbitrary detentions and suppression of dissent (2)(3). In 2024, the PA's attempts to implement legal reforms, such as the introduction of a Convention against Torture, have been overshadowed by ongoing violations, including arbitrary arrests of political opponents and activists (2).

The recent UN General Assembly resolution calling for an end to Israeli occupation, backed by 124 countries, reflects a growing international consensus against the status quo (5). This resolution demands Israel terminate its unlawful presence in Palestinian territories within a year and has been hailed by Palestinian leaders as a pivotal moment in their struggle for self-determination (5). However, Israel's response has been dismissive, framing the resolution as politically motivated and ignoring its implications for peace negotiations (5).

#### **Economic Context**

The economic conditions in Palestine are severely impacted by the ongoing blockade of Gaza and restrictions on movement in the West Bank (3). The blockade has led to widespread poverty, unemployment, and limited access to essential services such as healthcare and education (6). The humanitarian crisis in Gaza has been exacerbated by military operations that have resulted in extensive destruction of infrastructure, further crippling economic opportunities for the 2.2 million residents (6).

The economic disparity between Gaza and the West Bank continues to grow, with many Palestinians facing dire living conditions (6). The lack of a comprehensive domestic violence law also highlights systemic issues affecting women's rights within Palestinian society (3).

#### **Social Context**

Socially, Palestinians continue to endure significant human rights violations amid escalating violence. The recent conflict marked by attacks from both Hamas and Israeli forces has led to unprecedented civilian casualties. Reports indicate that over 18,700 Palestinians were killed during military operations from October 2023 to December 2023 alone (7). The pervasive violence has not only resulted in loss of life but has also led to mass displacement; approximately 1.9 million people were displaced from their homes during this period (7).

Civil society organizations face increasing challenges as civic space diminishes under both Israeli military actions and PA governance (8). Human rights defenders have reported intimidation and violence aimed at silencing dissenting voices (8). This environment stifles any meaningful dialogue on human rights improvements or accountability for abuses committed by both state and non-state actors (8).

# **Significant Events**

Key events influencing the human rights landscape include:

#### October 7 Attacks:

Initiated by Hamas militants, these attacks resulted in significant civilian casualties in Israel and prompted a severe military response from Israel against Gaza, leading to widespread destruction and humanitarian crises (1)(3).

#### **UN General Assembly Resolution:**

Passed on September 18, 2024, this resolution calls for an end to Israeli occupation within a year. It signifies international discontent with ongoing violations of international law concerning Palestinian territories (5).

#### **Escalation of Violence:**

Throughout 2024, violence has surged not only in Gaza but also in the West Bank, with reports of excessive use of force by Israeli security forces resulting in numerous Palestinian deaths (1)(3).

In conclusion, the human rights situation in Palestine remains precarious amid ongoing conflict and political instability. The interplay between local governance failures, external military actions, and international diplomatic efforts shapes a complex landscape where human rights continue to be systematically violated. Without significant changes in policy or international engagement aimed at accountability and justice, prospects for improvement remain bleak (1)(3).

# Civil and Political Rights

The civil and political rights situation in Palestine during 2024 is marked by severe restrictions on fundamental freedoms, including freedom of expression, assembly, and protection from arbitrary arrests and torture. The ongoing conflict and political turmoil have created an environment rife with human rights violations, significantly impacting the Palestinian population.

## Freedom of Expression

In 2024, freedom of expression in Palestine has faced unprecedented challenges. The Israeli military operations in Gaza have led to a near-total ban on foreign journalists and significant restrictions on local media outlets. This has resulted in a dramatic decline in the ability of journalists to report freely, with at least 108 media workers reportedly killed since the onset of hostilities in October 2023. The situation has been described as an "all-out assault" on the right to free speech, obstructing vital reporting on humanitarian crises and perpetuating cycles of violence and disinformation<sup>1</sup>.

The Palestinian Authority (PA) has also faced criticism for its suppression of dissent. Activists and journalists who criticize the PA or express solidarity with Gaza have experienced harassment, intimidation, and arrest. Reports have documented arbitrary detentions of individuals for posting critical opinions on social media, further chilling public discourse<sup>2</sup>.

# Freedom of Assembly

The right to peaceful assembly is severely restricted in both Gaza and the West Bank. Demonstrations against Israeli military actions have frequently met with forceful crackdowns by security forces. In recent months, numerous protests calling for an end to violence have been violently dispersed, with participants facing arrests and physical abuse. The PA's response to protests has included deploying riot police to suppress gatherings, often under the pretext of maintaining public order<sup>3</sup>.

Significant events, such as Nakba Remembrance Day, have seen heightened tensions, with authorities imposing restrictions on gatherings commemorating the displacement of Palestinians. This has led to accusations that the PA is prioritizing its political survival over the fundamental rights of its citizens<sup>4</sup>.

# **Arbitrary Arrests and Torture**

Arbitrary arrests remain a pervasive issue within Palestinian territories. Reports indicate that both Israeli forces and the PA engage in widespread arbitrary detention practices. The PA has been accused of targeting political opponents and activists critical of its governance, often detaining them without charge or trial<sup>5</sup>.

Instances of torture and ill-treatment during detention are alarming. Human rights organizations have documented cases where detainees were subjected to physical abuse

and psychological torture while in custody. The lack of accountability for these abuses perpetuates a culture of impunity among security forces<sup>6</sup>.

## **Government Responses**

Responses from both the PA and Israeli authorities to these human rights violations have been largely inadequate. The PA has failed to implement necessary reforms to protect civil liberties or hold security forces accountable for abuses. Instead, it has often resorted to repressive measures against dissenters while ignoring calls for transparency and justice from civil society organizations<sup>7</sup>.

On the Israeli side, military operations are justified under national security concerns but frequently result in excessive use of force against civilians. The international community's response has been criticized as insufficient, with calls for investigations into these violations often met with resistance from Israeli officials, who dismiss them as politically motivated<sup>8</sup>.

# **Overall Impact on the Population**

The cumulative effect of these violations is a profound sense of fear and disillusionment among the Palestinian population. Many individuals feel unable to express their opinions freely or participate in civic life without risking arrest or violence. This environment stifles not only political dissent but also social cohesion within communities struggling against external pressures.

As civil society organizations continue to document these abuses, there is a growing call for international intervention to protect Palestinian rights and hold violators accountable. However, without substantial changes in both local governance and international diplomatic engagement, the prospects for improvement remain bleak.

In summary, the civil and political rights situation in Palestine during 2024 is characterized by significant repression across various dimensions—freedom of expression is stifled, assemblies are violently suppressed, arbitrary arrests are commonplace, and instances of torture persist unchecked. The ongoing conflict exacerbates these issues, leaving the Palestinian population grappling with severe limitations on their fundamental rights.

# Rights of Specific Groups

The human rights situation in Palestine during 2024 has been marked by severe violations, particularly affecting women, children, LGBTQ+ individuals, and ethnic or religious minorities. The ongoing conflict and political instability have exacerbated existing inequalities and discrimination, posing significant challenges to the rights and safety of these vulnerable groups.

#### Women

Palestinian women have faced disproportionate suffering amid the escalating violence. The UNFPA estimates that over 1 million women and girls lack access to essential sexual and reproductive health services. Many are forced to give birth under perilous conditions due to the attacks on hospitals and the obstruction of humanitarian aid[3]. Consequently, maternal and neonatal mortality rates have risen sharply, with a staggering 300% increase in miscarriages reported between October and December 2023[5].

Additionally, women are at heightened risk of gender-based violence, including sexual exploitation and intimate partner violence, especially in overcrowded shelters[5]. Discriminatory personal status laws persist, affecting women's rights in marriage, divorce, child custody, and inheritance. Although the Palestinian Authority (PA) has considered a draft family protection law, women's rights groups argue that it falls short of adequately preventing abuse or protecting survivors[8].

#### Children

Children in Palestine have borne the brunt of the violence, with 70% of the over 40,000 casualties being women and children[3][4]. Thousands have been orphaned or injured, and many are at risk of early and forced marriage as families seek to cope with the instability[5]. The lack of access to education and counseling services has perpetuated misconceptions and normalized gender-based violence, severely threatening the healthy development of an entire generation[5].

# **LGBTQ+ Individuals**

The situation for LGBTQ+ individuals in Palestine remains precarious, characterized by limited legal protections and societal acceptance. Although the PA has made some attempts to address discrimination based on sexual orientation or gender identity, significant gaps remain in ensuring the rights and safety of this community[2]. The social stigma surrounding LGBTQ+ identities further exacerbates their vulnerability, often leaving them without support or recourse.

# **Ethnic and Religious Minorities**

Ethnic and religious minorities, particularly Bedouin communities, continue to face significant challenges, including ongoing displacement, home demolitions, and restricted access to vital resources and services in the West Bank[8]. The Israeli occupation, coupled with internal divisions, has heightened tensions and marginalization, placing these minority groups in precarious situations often exacerbated by the broader conflict.

# **Progress and Challenges**

Despite the dire circumstances, some positive developments have occurred in 2024. The PA has taken steps to ratify the Convention against Torture and its Optional Protocol, integrating it into Palestinian law[8]. Additionally, the UN Subcommittee on Prevention of Torture has conducted visits to detention facilities in the West Bank, although reports of arbitrary arrests and torture allegations persist[8].

However, the ongoing conflict and political instability continue to hinder meaningful progress. The Israeli blockade of Gaza and restrictions in the West Bank have crippled the economy and access to essential services, disproportionately impacting vulnerable groups[8]. Furthermore, the lack of accountability for human rights violations and the absence of a comprehensive legal framework to protect the rights of all Palestinians remain significant obstacles.

In conclusion, the human rights conditions for specific groups in Palestine during 2024 have been marked by widespread violations and limited progress, particularly for women, children, LGBTQ+ individuals, and ethnic or religious minorities. Addressing these pressing issues requires a concerted effort from all stakeholders to prioritize human rights, ensure accountability, and work towards a just and sustainable peace.

In 2024, the ongoing conflict in Palestine has severely compromised the economic, social, and cultural rights of its population, particularly in Gaza. The deterioration of the right to health, education, and adequate housing reflects a dire humanitarian crisis, compounded by the aftermath of the October 7 attacks and subsequent military operations.

# Right to Health

The right to health in Palestine, especially in Gaza, is facing an unprecedented crisis. The healthcare system is teetering on the brink of collapse, with extensive damage to medical infrastructure and acute shortages of essential supplies. By May 2024, 31 out of 36 hospitals in Gaza had been damaged or destroyed, including the pivotal Al-Shifa Hospital. The remaining facilities are operating under immense strain, grappling with a surge of casualties and a critical lack of resources [1].

Access to healthcare has become alarmingly difficult, highlighted by reports of numerous attacks on health facilities across the region [2]. The dire situation is further exacerbated by fuel shortages, which are essential for sustaining life-saving medical services. The healthcare sector in Gaza requires a daily supply of 80,000 liters of fuel, yet the available supply falls woefully short, severely limiting the capacity for trauma care, emergency surgeries, and other critical medical interventions [3].

# **Right to Education**

The right to education is similarly under siege, with the ongoing conflict wreaking havoc on educational institutions. Many schools have been damaged or destroyed, forcing children to flee their homes and disrupting their education [4]. In Gaza, where over 1.7 million individuals have been displaced, the educational landscape has been transformed into a crisis zone. Makeshift shelters and overcrowded living conditions have severely limited access to basic educational services [5].

The long-term implications of this disruption are alarming. Children in Palestine are at risk of missing crucial learning opportunities that are vital for their development and future prospects. The loss of educational continuity not only hampers academic achievement but also affects the psychological and social well-being of these young individuals [6].

# **Right to Adequate Housing**

The right to adequate housing has been catastrophically undermined by the destruction wrought during military operations. With an estimated 10,000 individuals still missing under rubble, entire neighborhoods have been reduced to ruins, leaving a staggering number of people displaced [7]. Many are now seeking refuge in makeshift shelters that lack basic necessities, including clean water and sanitation facilities [8].

The unsanitary conditions faced by displaced individuals pose significant health risks, increasing the likelihood of disease outbreaks. This situation further compounds the already

precarious health conditions in Gaza, creating a vicious cycle that undermines the right to health as well [9].

## Conclusion

In conclusion, the economic, social, and cultural rights in Palestine have been profoundly compromised in 2024, particularly in Gaza. The right to health, education, and adequate housing has been gravely undermined, leading to a humanitarian crisis with far-reaching consequences for the population. The extensive destruction of medical infrastructure, educational facilities, and housing has created a situation that demands urgent intervention. Without immediate action to address these violations and uphold the rights of Palestinians, the prospects for recovery and development remain bleak.

# Refugees and Migrants

The plight of refugees, asylum seekers, and migrant workers in Palestine during 2024 has reached alarming levels, characterized by systemic rights violations and profound humanitarian challenges. The ongoing conflict, especially the violence that erupted in October 2023, has significantly exacerbated the conditions faced by these vulnerable groups [1].

# **Treatment of Refugees**

#### **Living Conditions**

Palestinian refugees, particularly those living in overcrowded camps, endure deteriorating living conditions. Reports indicate that many camps suffer from high population density, inadequate infrastructure, and a severe lack of basic services such as clean water and sanitation. Military operations have resulted in the destruction of homes and vital infrastructure, leaving many without proper shelter [2]. This neglect not only affects daily survival but also undermines the dignity of these individuals [3].

#### **Access to Asylum Procedures**

Access to asylum procedures is alarmingly restricted for Palestinian refugees. The lack of recognition from numerous countries limits their resettlement options, forcing many to remain trapped in a cycle of displacement. The escalation of violence and instability in 2024 has further complicated efforts to navigate existing asylum processes, leaving countless refugees with little hope of finding safety or stability [4].

## **Instances of Exploitation and Abuse**

Exploitation and abuse of refugees are rampant, especially in labor markets where discrimination is common. Many refugees work under harsh conditions for meager wages, with little to no legal protections against exploitation. Migrant workers from other regions face similar vulnerabilities, often subjected to substandard working conditions without recourse to justice [5].

# **Treatment of Asylum Seekers**

Asylum seekers in Palestine confront substantial barriers to legal protections and support. The ongoing conflict creates an environment where asylum claims are often overlooked amid the pressing humanitarian crisis. Many individuals fleeing violence and persecution struggle to navigate the complex legal landscape, further complicating their dire situations [6].

#### **International and Domestic Responses**

International responses have largely centered on immediate humanitarian aid, with organizations like UNRWA striving to provide essential services such as healthcare and

education. However, funding shortages have severely hindered their ability to meet the growing needs of the population. In 2024, UNRWA reported critical resource shortages, struggling to maintain support amidst escalating humanitarian crises [7].

On the domestic front, the Palestinian Authority has faced criticism for its inadequate response to the needs of refugees and asylum seekers. Calls for reforms to improve access to services and protections have surfaced, yet political instability and ongoing violence have stymied meaningful progress [8]. The failure to address these systemic issues only perpetuates the cycle of suffering for these vulnerable groups [9].

#### Conclusion

In summary, the situation for refugees, asylum seekers, and migrant workers in Palestine during 2024 is marked by severe rights violations and systemic neglect. Living conditions remain dire, access to asylum procedures is critically limited, and instances of exploitation are pervasive. The international community's focus on immediate humanitarian needs, rather than addressing the root causes of these issues, is deeply concerning. Without significant changes in both domestic policies and international support frameworks, the plight of these vulnerable groups is unlikely to improve.

# Legal Framework and Accountability

The legal framework and accountability mechanisms for human rights in Palestine during 2024 present a troubling landscape, rife with challenges stemming from ongoing violence and political instability. Despite some attempts at reform, the situation remains characterized by inadequate legal protections, widespread impunity for human rights violations, and limited progress towards meaningful accountability <sup>1</sup>.

# **Legal Framework and New Legislation**

In 2024, the Palestinian Authority (PA) has made tentative steps towards reforming its legal framework. Notably, discussions have emerged around ratifying the Convention against Torture and its Optional Protocol, signaling a potential commitment to combatting torture and ill-treatment <sup>2</sup>. However, skepticism persists regarding the PA's ability to implement these reforms effectively, given its ongoing struggles with governance and the erosion of public trust <sup>3</sup>.

Additionally, various legislative initiatives aimed at enhancing governance and accountability have been proposed, including plans to modernize the judiciary and expand media freedoms. These initiatives are part of a broader agenda to address systemic issues within Palestinian governance <sup>4</sup>. Nevertheless, historical patterns of unfulfilled promises cast doubt on the PA's political will to follow through with these reforms <sup>5</sup>.

# Role of the Judiciary

The judiciary in Palestine operates under considerable constraints, heavily influenced by political pressures and a lack of independence. Many judges are appointed by the PA president, raising serious concerns about impartiality and adherence to the rule of law <sup>6</sup>. The judiciary's effectiveness is further undermined by ongoing conflicts and a dire lack of resources, which leads to significant delays in delivering justice for victims of human rights abuses <sup>7</sup>.

Calls for judicial reforms to foster greater independence and professionalism have surfaced in 2024, but these demands have yet to manifest in meaningful changes <sup>8</sup>. The absence of an independent judiciary perpetuates a culture of impunity, allowing perpetrators of human rights violations to evade accountability <sup>9</sup>.

# **Impunity for Human Rights Violations**

Impunity remains a pervasive issue in Palestine, with numerous cases of human rights violations going unpunished <sup>10</sup>. Reports indicate that both Israeli forces and PA security forces engage in practices that violate international human rights standards without facing legal repercussions <sup>11</sup>. Allegations of torture and ill-treatment during detention are common, yet investigations into these abuses remain rare <sup>12</sup>.

Specific cases illustrate this entrenched impunity. Following violent crackdowns on protests against military operations in Gaza, several individuals were arrested by PA security forces

for participating in peaceful demonstrations. Despite calls for accountability from civil society organizations, no substantial actions have been taken against those responsible for the excessive use of force <sup>13</sup>.

Conversely, there have been instances where international scrutiny has prompted some degree of accountability. In 2024, a few cases involving Israeli military personnel accused of unlawful killings were investigated; however, these investigations typically result in minimal consequences or are dismissed altogether, highlighting the ineffectiveness of existing mechanisms <sup>14</sup>.

#### Conclusion

In summary, the legal framework and accountability mechanisms related to human rights in Palestine during 2024 reflect a landscape fraught with challenges <sup>15</sup>. Although there are efforts to reform laws and enhance judicial independence, significant barriers remain due to political instability and entrenched impunity for human rights violations <sup>16</sup>. The lack of effective accountability mechanisms continues to undermine public trust in governance and perpetuates a cycle of abuse that disproportionately affects the most vulnerable populations in Palestinian society <sup>17</sup>. Without genuine commitment to reform and accountability from both local authorities and the international community, the prospects for meaningful change remain bleak <sup>18</sup>.

# International Relations and Human Rights

In 2024, Palestine's international relations regarding human rights have been heavily influenced by the ongoing conflict and the subsequent advocacy efforts surrounding human rights violations. [1] The engagement with various UN bodies has become a focal point for the Palestinian Authority (PA), which has sought to bring attention to alleged war crimes and demand accountability for the high civilian death toll resulting from Israeli military actions in Gaza. [2] The PA's appeals for an arms embargo and sanctions against Israel reflect a desperate attempt to garner international support, labeling these actions as genocidal, particularly concerning the tragic loss of women and children. [3]

Despite these efforts, the PA faces a complex and often unyielding geopolitical landscape. [4] While the UN General Assembly has considered resolutions calling for an end to the Israeli occupation and has recognized the International Court of Justice's ruling against Israel's presence in Palestinian territories, the results have frequently been stymied by opposition from powerful allies like the United States. [5] This has created a scenario where vocal condemnations of Israeli actions exist in tandem with a significant lack of concrete measures—such as sanctions or arms embargoes—that could potentially hold Israel accountable. [6]

International pressure on Israel has indeed intensified, driven by human rights organizations and certain member states that advocate for accountability. [7] Reports documenting systemic abuses, including arbitrary arrests and collective punishment against Palestinians, have led to increased calls for sanctions. [8] However, the absence of a unified international response often stems from nations prioritizing strategic alliances over human rights considerations. [9] The outcome is a dichotomy: widespread acknowledgment of the human rights crisis in Palestine, but minimal action that translates into real change. [10]

The implications of these international dynamics on the domestic human rights situation in Palestine are profound. [11] While the PA seeks to enhance its legitimacy through international endorsements, it concurrently grapples with internal issues, including its own human rights abuses. [12] The suppression of dissent through arbitrary arrests and restrictions on freedom of expression not only undermines the PA's credibility but also raises concerns about governance and accountability. [13] Moreover, the humanitarian crisis in Gaza, which has captured global attention, remains politically charged. [14] Humanitarian aid is often contingent upon political negotiations rather than purely humanitarian needs, which exacerbates the existing vulnerabilities faced by Palestinian populations. [15]

In summary, Palestine's international relations concerning human rights in 2024 illustrate a complex interplay of advocacy and geopolitical challenges. [16] Despite increased engagement with UN bodies and a growing clamor for accountability regarding Israeli actions, the international community's limited pressure reveals a troubling reality. [17] The PA's struggle for legitimacy amid its own human rights violations complicates efforts to improve the overall situation. [18] Without a concerted international effort to hold violators accountable and to support meaningful reforms within Palestinian governance structures, the prospects for enhancing human rights conditions in Palestine remain grim. [19]

# Recommendations

The human rights situation in Palestine demands urgent and systematic reforms from all stakeholders, including the Palestinian Authority (PA), international bodies, and civil society organizations. The following recommendations provide a critical framework for addressing ongoing violations and promoting accountability, justice, and the protection of fundamental rights.

# **Recommendations for the Palestinian Authority**

#### 1. Prioritize Legal Frameworks:

The PA must move beyond rhetoric and actively ratify and implement international human rights treaties, notably the Convention against Torture. This commitment should be accompanied by comprehensive legislation that explicitly criminalizes torture and arbitrary detention, ensuring that these protections are not merely symbolic.

#### 2. Reform the Judiciary:

A judiciary that is free from political manipulation is non-negotiable. The PA should establish a transparent process for judicial appointments based on merit, alongside robust training programs for judges on human rights law. Only then can the judiciary serve as a credible check on executive power.

# 3. End Human Rights Violations by Security Forces:

The PA must institute immediate and mandatory human rights training for all security personnel. Establishing independent oversight bodies to investigate allegations of misconduct is essential; without accountability, violations will persist.

# 4. Protect Vulnerable Populations:

The PA's policies must explicitly address the needs of women, children, LGBTQ+ individuals, and ethnic or religious minorities. This includes creating mechanisms for reporting abuses and ensuring access to justice for these groups, rather than merely issuing statements of intent.

#### 5. Facilitate Humanitarian Access:

It is imperative for the PA to cooperate fully with international humanitarian organizations, ensuring unfettered access to Gaza and the West Bank. This includes not only logistical support but also political backing to enable these organizations to function effectively.

# **Recommendations for International Bodies**

#### 1. Implement Targeted Sanctions:

International bodies should take decisive action by imposing targeted sanctions on individuals or entities found guilty of severe human rights violations. This measure would signal that impunity for abuses will not be tolerated.

#### 2. Support Independent Investigations:

There is a pressing need for independent international investigations into human rights abuses committed by all parties involved in the conflict. International bodies should provide funding and logistical support to facilitate these investigations, ensuring that accountability becomes a reality.

#### 3. Advocate for Arms Embargoes:

A comprehensive arms embargo on both Israel and Palestinian armed groups is essential until there is a clear commitment to cease violence against civilians. This must be a priority for international bodies aiming to uphold human rights standards.

#### 4. Increase Humanitarian Aid:

Humanitarian aid must not only be increased but also targeted to address the immediate needs of affected populations. International bodies should prioritize funding for health services, education, and housing reconstruction in Gaza and the West Bank.

## 5. Utilize Diplomatic Leverage:

International actors must employ diplomatic channels to compel Israel to halt its practices of collective punishment. This includes lifting the blockade on Gaza, which has exacerbated humanitarian crises and violated the rights of countless individuals.

# **Recommendations for Civil Society Organizations**

# 1. Enhance Advocacy Campaigns:

Civil society organizations must step up their advocacy efforts, utilizing both grassroots initiatives and international platforms to expose human rights violations in Palestine. This requires a strategic focus on mobilizing local and global support.

# 2. Document Violations Diligently:

Continuous and meticulous documentation of human rights abuses is critical for accountability. Civil society must collaborate with international human rights organizations to amplify their findings, ensuring that these violations are recognized on the global stage.

#### 3. Empower Communities:

Educational programs that inform communities about their rights and available legal protections are essential. Workshops focused on civic engagement and governance can empower individuals to hold authorities accountable.

#### 4. Provide Support for Victims:

Establishing comprehensive support networks for victims of human rights abuses is crucial. This includes legal aid, psychological counseling, and rehabilitation programs to help victims recover and reintegrate into society.

#### 5. Build International Solidarity:

Civil society organizations should actively seek partnerships with global human rights advocacy groups. Building solidarity movements can amplify voices calling for justice and support for Palestinian rights, fostering a broader commitment to human rights.

#### Conclusion

The path to improving the human rights situation in Palestine is fraught with challenges, but it is achievable through concerted and decisive action from the PA, international bodies, and civil society. These recommendations highlight the need for systemic changes, accountability mechanisms, and community empowerment. Only by addressing the root causes of human rights violations can we hope to build a just society where all individuals can enjoy their fundamental rights free from repression and violence.

# Conclusion:

The 2024 Human Rights Report on Palestine underscores the grave and persistent human rights issues affecting the region, marked by escalating violence and systemic violations. The data presented reveals an alarming toll: over 34,800 fatalities in the Gaza Strip, with a significant portion being civilians, including children and women. In the West Bank, the record-high fatalities caused by Israeli forces demonstrate the urgent need for accountability and justice.

The report highlights the severe implications of administrative detention, with nearly 3,000 Palestinians held without charge, raising profound concerns regarding due process and the rule of law. Additionally, the violence inflicted during the October 7 assault illustrates the dire consequences of ongoing hostilities, with substantial civilian casualties resulting from both Palestinian armed groups and Israeli military actions.

These findings not only reflect a crisis in human rights but also indicate a broader pattern of violations that warrant immediate and sustained international attention. The importance of continued monitoring cannot be overstated, as it is essential for promoting accountability, safeguarding human dignity, and advocating for the rights of affected populations.

In conclusion, it is imperative for the global community, regional actors, and human rights organizations to remain vigilant and proactive in addressing these critical issues. By fostering dialogue, supporting humanitarian efforts, and pushing for legal and institutional reforms, we can strive towards a future where human rights are respected and upheld for all individuals in Palestine. Only through concerted efforts can we hope to alleviate the suffering of those impacted and work towards a just and lasting resolution to the ongoing human rights crisis in the region.

- **War Crimes:** Serious violations of the laws of war that include willful killing, torture, taking hostages, and attacks against civilians.
- **Crimes Against Humanity:** Widespread or systematic attacks against civilian populations, including extermination, murder, and gender persecution.
- Administrative Detention: Holding individuals without charge or trial based on secret information; often criticized for lack of due process.
- Human Shields: The use of civilians to deter attacks on combatants or military objectives.
- **Gender-Based Violence (GBV)**: Harmful acts directed at individuals based on their gender; includes sexual violence and harassment.
